EM's first priority is to ensure the safety and health of the public and EM's workforce while continuing to protect the environment. OREM carries out the mission using sound business practices, innovative management approaches, and science and technology to reduce risks and costs within the EM regulatory framework.

The Fellow will receive training, coaching and mentoring from the EM-92 branch chiefs to effectively accomplish appointment goals. Appointments may involve projects focused on engineering, science, research, technology, policy, business, and government relations.

The Fellows will collaborate with Portfolio Federal Project Directors on all aspects of their projects such as; basic project management, engineering, budget, cost control, regulatory compliance, and contractor oversight.

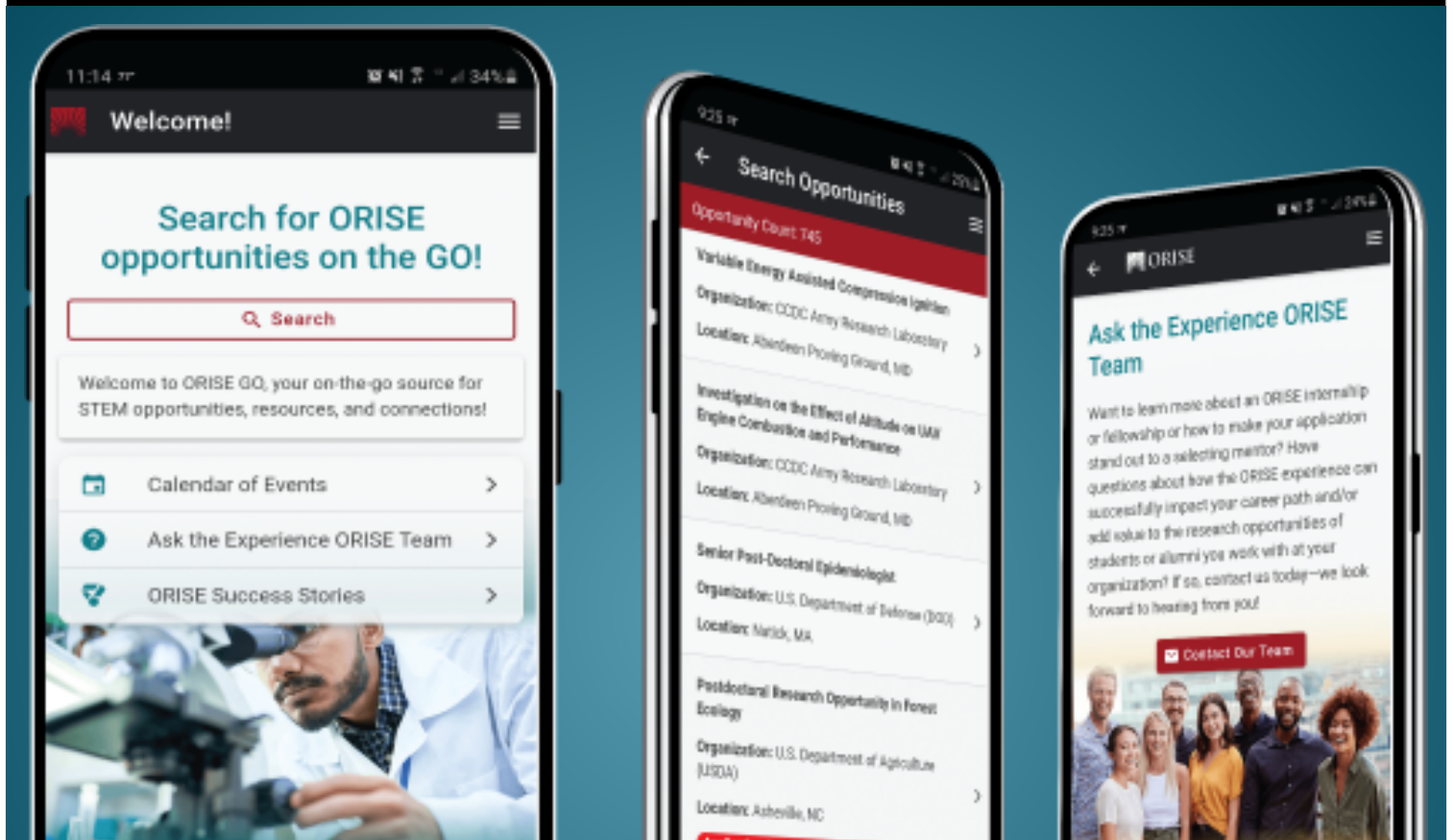
