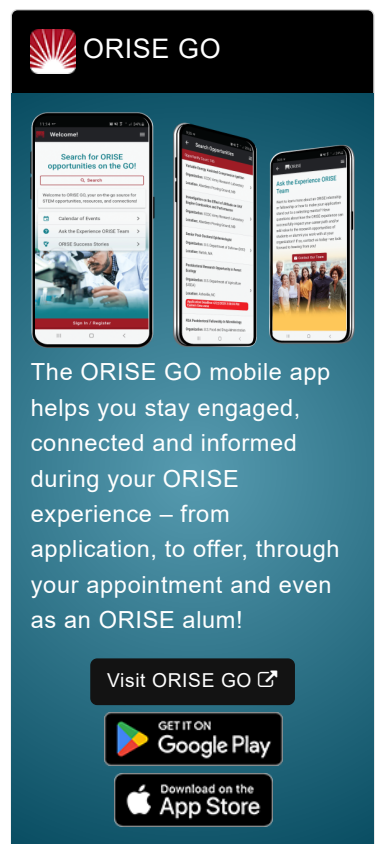

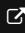

Project activities will include supporting an assessment of the Midwest Climate Hub's role in facilitating ag-climate research, communications, and outreach. Activities will also include assessing regional climate services, which include webinars, stakeholder outreach, mass communications, and partnership development.

Learning Objectives: These project activities will help inform future climate services research in the Midwest while providing the candidate with opportunities to learn more about Midwest agricultural systems, conduct data analysis, review research, and co-create publications and outreach materials for a variety of audiences. The candidate will collaborate with the USDA Climate Hubs and many climate service partners in the region.
