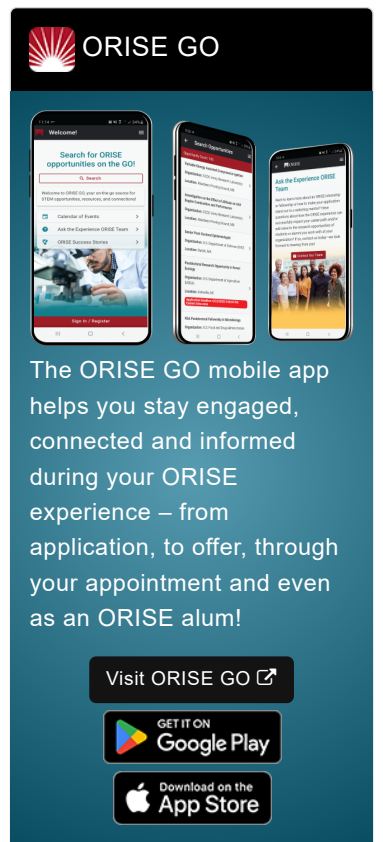

Interns are provided a stipend and various allowances to support them during the internship. The allowances vary with the cost of living at the location and with the mode of participation (in-person or virtual).

Basic Stipend:

Undergraduate students: \$750/week

Graduate students: \$950/week

Post-Baccalaureate: \$850

Post-Master's students: \$1050/week

Post-doctoral students: \$1150/week

In-person Internship Allowances:

Travel: You will be reimbursed up to **\$1,000** for inbound/outbound transportation expenses from your current address to the assigned location if the distance is over 50 miles. Travel arrangements and reimbursement will be based on the most direct and expeditious mode of transportation; ORISE is available to make travel arrangements and purchase plane or train tickets for participants if requested. Your travel to and from orientation in Washington, D.C. will also be covered.

Housing: If you relocate more than 50 miles one-way from your current location, you will be eligible for a weekly housing supplement to offset expenses associated with housing during the internship. Supplement levels depend on the location of your internship and will vary from **\$374 - \$777/week**. This supplement will be added to your weekly stipend.

Commute: A **\$50/week** supplement will be provided to offset the cost of commuting to and from your internship site.

Virtual Internship Allowances:

Virtual interns will receive a **\$150/week** supplement to offset the cost of remote participation. The supplement will be added to the stipend.

Your travel to and from orientation in Washington, D.C. will be covered.

Optional Benefits:

At their discretion, offices may offer supplements to offset the cost of health insurance, for educational and professional development support, and for travel during the internship.

Review of Applications

Applications will be evaluated by the sponsoring offices/hosting facilities to determine if there is a match between your knowledge, skills, and interests, and the projects available. Applications may be reviewed by multiple mentors at the same time. Sponsoring offices/hosting facilities may contact you for an interview prior to selection.

Nature of Appointment:

Interns will not enter into an employee/employer relationship with ORISE, ORAU, MEISPP or the hosting site. Instead, interns will be affiliated with ORISE for the administration of the appointment through the ORISE appointment letter and *Terms of Appointment*.

About the Office of Economic Impact and Diversity (ED):

The MEISPP program is sponsored by ED. The ED develops and executes Department-wide policies to strengthen diversity and inclusion goals affecting equal employment opportunities, small and disadvantaged businesses, minority educational institutions and historically under-represented communities.

Qualifications Candidates must meet the eligibility conditions outlined for the program by the program start (June 5th, 2023). A candidate must:

- Be at least 18 years of age.
- Be a U.S. citizen.
- Have a cumulative GPA of at least 3.0 on a 4.0 scale.
- Be enrolled during the 2023-2024 academic year as a full-time degree-seeking student in a STEM program or other field that supports the DOE mission at an eligible Minority Serving Institution (MSI) OR have received a degree from an eligible MSI within the past two years. (Graduation no earlier than Spring semester 2022) The U.S. postsecondary institutions that meet the statutory criteria for identification as Minority Serving Institutions and are eligible for this program are listed here: <https://orise.orau.gov/MEISPP/msi-list.html>. A schools eligibility may change from year to year, so if you are a recent graduate, be sure to check for your graduation date! The MSI categories include:
 - AANAPISI - Asian American and Native American Pacific Islander Serving Institution
 - ANNH - Alaska Native and Native Hawaiian Serving Institution
 - HBCU - Historically Black College or University
 - HSI - Hispanic-serving institution
 - NASNTI - Native American-serving nontribal institution
 - PBI - Predominantly Black Institution
 - TCU - Tribal College or University
- Be available to participate in the full 12-week program.

Additional Eligibility Factors:

- Candidates selected for an internship appointment will be required to provide proof of enrollment during Spring 2024 term, OR for graduates, proof of graduation within the past two years (no further back than the Spring 2022 semester). Enrollment or graduation must be from a eligible

MSI; eligibility can change from year to year and for graduates the eligibility will be based on the list for year of graduation.

• Students may apply for and are eligible to participate in the program at multiple times during their undergraduate and graduate studies and as well as up to 2 years after graduation. However, there should not be an assumption or expectation of being re-selected.

A complete application consists of:

- All required fields in both the profile and application form, including responses to the following prompts:
 - Interests, Skills and Experience:
 - Explain why this opportunity interest you and how it will impact your educational and professional goals. Describe your relevant research, technical, or professional skills and experience that are applicable to this opportunity.
 - Program Participation
 - Do you currently participate or have you previously participated in an ORAU or ORISE educational program?
 - If yes, list all project/assignment(s) in which you have participated including dates, location, and mentor for each assignment.
- Resume (PDF, 2-page limit)
- Academic Records
 - A copy of an official or unofficial transcript or copies of the student academic records printed by the applicant or by academic advisors from internal institutional systems may be submitted. Transcript or academic records must clearly show:
 - student name
 - name of the academic institution
 - enrollment during the academic term at the time of application OR degree completion within the past 2 years (not earlier than Spring 2022)
 - current/completed/enrolled courses, grades, most recent cumulative GPA, and degree in progress OR degree completed.
 - *Submitted documents must have all social security numbers, student identification numbers, and/or dates of birth removed (blacked out, blackened out, made illegible, etc.) prior to uploading into the application system.*
- Academic or Professional Recommendation: Recommendation should address the applicant's academic record and potential for success in an appointment, such as demonstrated intellectual merit, communication and teamwork skills. Recommenders will be asked to submit a recommendation in Zintellect. Letters of recommendation submitted via email will not be accepted.
