This training opportunity will provide fellows with training to prepare current students and recent graduates for careers in public health law and policy. The Office of Public Health Law Services Fellowship was created to strengthen the public health law workforce by increasing diversity within the field and preparing the next generation of public health law professionals to respond to critical issues.
